8. **For Discussion:** Discussion related to HIV medication and getting a protected class status for all HIV meds, which would require all insurances in Nevada to cover all treatment options as pharmacy benefits, prohibiting co-pay accumulation, and prohibiting them from moving medications for the treatment of HIV or related conditions (i.e., Syphilis to medical benefits coverage). – Rob Phoenix, APRN, FNP-C, HIV-PCP
9. **For Discussion:** Discussion related to HIV prevention services and medications and mandate for all Nevada insurances to cover all preventive services and medications, also requiring all Nevada insurances to cover all HIV prevention medications, as well as treatment for any STI such as syphilis, as pharmacy benefits, not medical benefits. Lastly, also prohibiting co-pay accumulation. - Rob Phoenix, APRN, FNP-C, HIV-PCP
