Nevada's Ending the Epidemic Workgroup Meeting Agenda Monday, March 13th, 2023, 12–1 PM PT

Updates:

RW Part A: Recruitment applicant for the Rapid Start Coordinator was approved, still wanting on acceptance from the county. They are working on the Rapid stART manual which is a guide for agencies that will be joining the response team. A management analyst position for rapid StART that will be posted now. They received full EHE award last week Thursday with a little over 2M, ~ \$450,000 increase over last year. U=U had a soft launch this week, planning an event with talent from the U=U campaign. Determining priorities for new year and will keep group posted.

RW Part B: Not present

SNHD/Fast Track Cities: Rethink HIV campaign is running again. New rethink safe sex campaign for youth ages 18 to 25 is coming; website design and video production with start soon. Working with Washoe County Health department to put their condom link on their rethink safe sex website. They are preparing for an Empower Change training in April and another in July.

WCHD: Partnering with Rethink HIV campaign. Jail Syphilis project has seen some slowdowns, some positions in the STI area opening up.

CCHHS: RSR finished and finishing QI project.

State prevention programs: HIV prevention program is hiring health resource analyst and will be meeting with CDC partners soon.

PACE: On 3/15 from 9-12 PST, HHS is having an HIV summit in recognition of women and girls HIV AIDS awareness Day. On 4/10 there will a listen session before the Biomedical conference with coomunity partners.

Southern Nevada Health Consortium: On 2/28 they hosted HIV is not a crime town hall, panel discussion. 3/10 they hosted Its Tea Time, an afternoon tea in honor of National women and girls HIV awareness day with vendors, providers and community members. Their next meeting is 3/16 at Dignity Health to discuss upcoming events including social media campaign for National Native HIV Awareness Day on 3/20 and Transgender HIV testing day, programs for youth and HIV and National HIV testing day coming up in June.

PAETC: Introduced new program manager, Caitlin Firestone. There will be a listen session from 9-11:30 at Huntridge family clinic with PACE partners on 4/10, the day before the Biomedical conference in Las Vegas. They are figuring out registration now and would like to have a few

representatives from the different organizations. They are developing a brag sheet to have innovated programs from across the state all on one sheet to present to their PACE partners. In-person STI update, May 11th, it will be a full day event at the Las Vegas Water District.

Sage Brush: They signed a MOU to implement rapid start and hired a new nurse navigator, they are offering free PrEP services.

UMC Wellness: They had a pop-up HIV clinic at one of their quick care sites this past weekend. They are planning for the UMC Wellness Fair on Earth day, April 20th and collaborating with their SNHD partners who will be doing free HIV and STI testing from one of their mobile vans located at the Clark County Government Center.

There was a request to have next month's presentation focus on how the legislative process works and how people can get involved. It was acknowledged that many in the group needs to learn more and focus on continuing to educate themselves and others.
