Starting June 1, 2025, Dignity Health will begin centralized eligibility functions funded by Part A through the Referral for Healthcare and Support Services service category.

Although Dignity was selected to provide a majority of eligibility services for the Las Vegas Transitional Grant Area (TGA), some other agencies will play a role in eligibility due to the services they have contracts/subgrants to provide through Part B. Please adhere to the following guidance:

1. Because all Ryan White Parts in Nevada have universal eligibility criteria, the agencies listed below for Clark and Nye Counties will be making eligibility determination for Parts A, B, C, and D.

Clark County

- Access to Healthcare Network (AHN) will continue to handle eligibility for the clients to whom they provide Ryan White case management services. AHN will also continue to support AIDS Drug Assistance Program (ADAP) eligibility.
- AIDS Healthcare Foundation, Community Outreach Medical Center, and Southern Nevada Health District will continue to handle eligibility for the clients to whom they provide Ryan White case management services.

Nye County

- Nye County Health and Human Services will continue to handle eligibility for the clients to whom they provide Ryan White case management services.

2. *The agency at which eligibility services are delivered shall be responsible for submitting ADAP to AHN.*
3. *The agency at which eligibility services are delivered shall be responsible for uploading dental applications to CAREWare and to access the dental portal to update client information. **Do not send dental applications to AHN.***
4. *Aid for AIDS of Nevada will continue to provide Non-Medical Case Management for the clients that they currently provide case management, as well as HOPWA services.*
5. If case management client at any of the agencies listed above expresses, at the time eligibility is due, a desire to switch to another agency for their case management services, the agency shall make a referral to Dignity Health for eligibility services.
6. New clients in Clark County who present for services shall be referred to Dignity Health for eligibility services. New clients in Nye County who present for services shall be referred to Nye County Health & Human Services for eligibility services.

7. In **Mohave County**, CAN Community Health will support clients will completing paperwork and uploading it to Arizona's Ryan White eligibility hub. Eligibility determination will be made by the Arizona Department of Health Services.
